- Start removing towers in Spring 2026
- Traffic study will be done to determine how the tower removal will affect area traffic
- Work will be done between 9a 3p

HOW TOWERS WILL BE REMOVED

- Tarp will be laid down for wire removal
- Will shear tower into three (3) pieces to be put on truck by crane
- Dispose of tower properly
- Separate crew per tower base will come out 1 to 2 after tower removal to completely remove base and backfill the base area
