**BZA23-036 1080 & 1100 Obetz Road Columbus, OH 43207 :** The applicants were present representing themselves. This case requires some additional research by the Zoning Chair, however it is at its most basic level, a situation where the buyers of the lot wish to build a pole barn to store their tractor and mower, pick up trucks and other equipment needed to maintain the 5 plus acres of their 2 lots in. At a later time they may have plans to build a single family dwelling on the lot. The question that needs additional research is if the two lots can or can not be combined, and if the filing needs to be amended to do such. The Zoning Chair is investigating this with the City and will have an answer by the full Commission meeting.

This is an existing Amazon facility that the applicant is looking to re-sign for the purposes for clarifying the signs and making the traffic flow work better. The location is surrounded by other warehouses utilized by Amazon and supporting businesses.
